

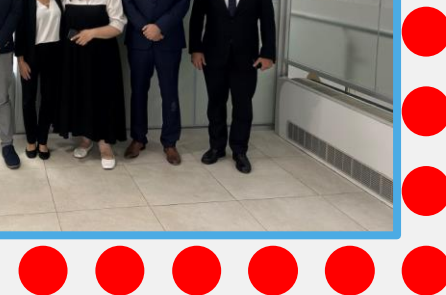
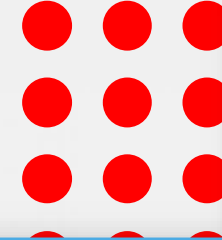


PARTNERSHIP OFFER

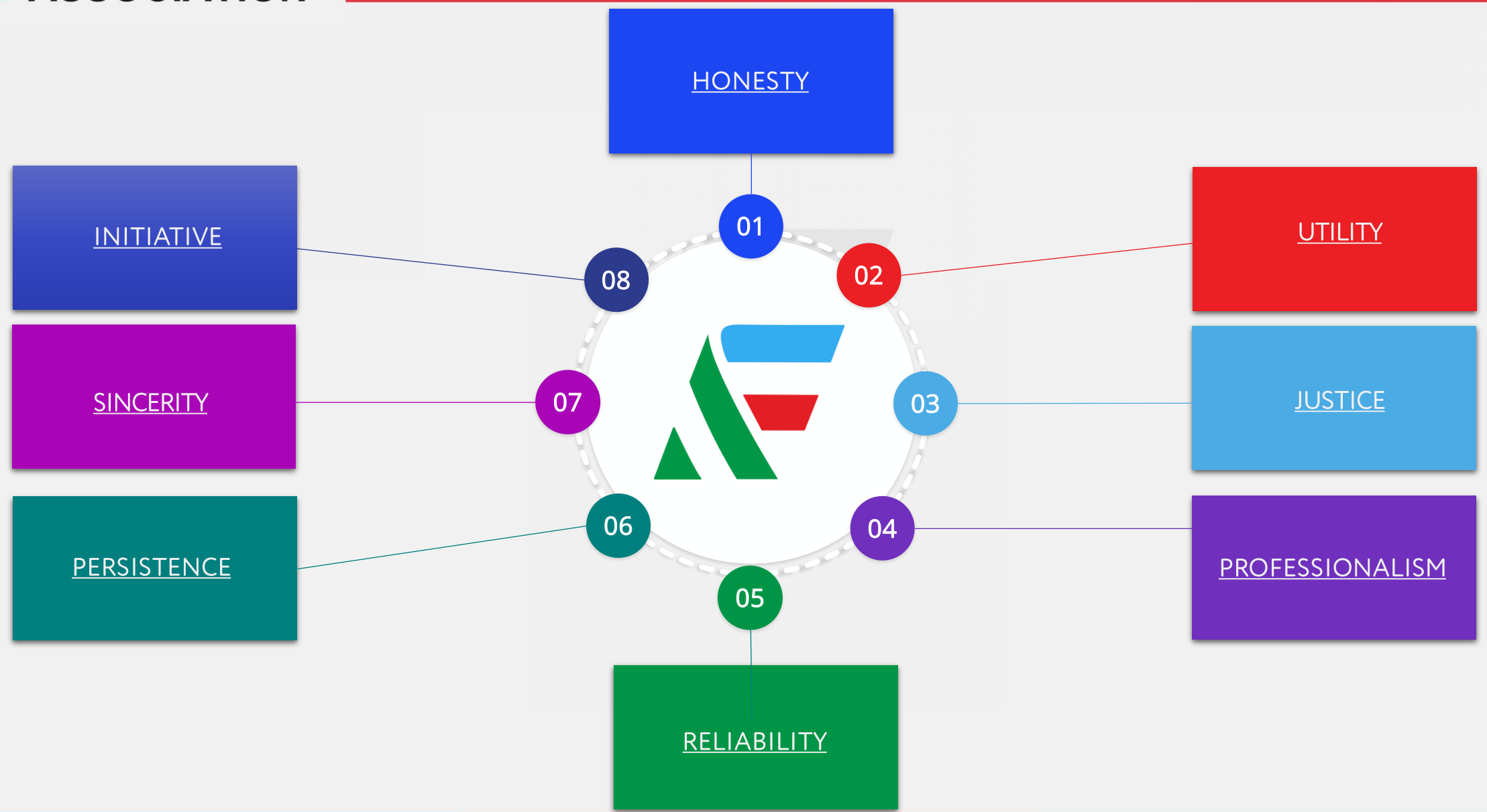

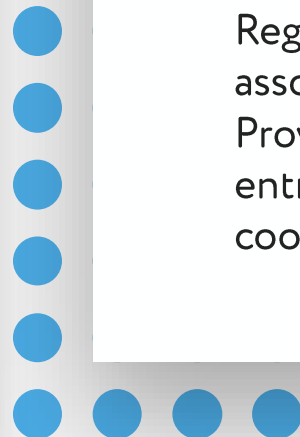
SUPPLIER SEARCH

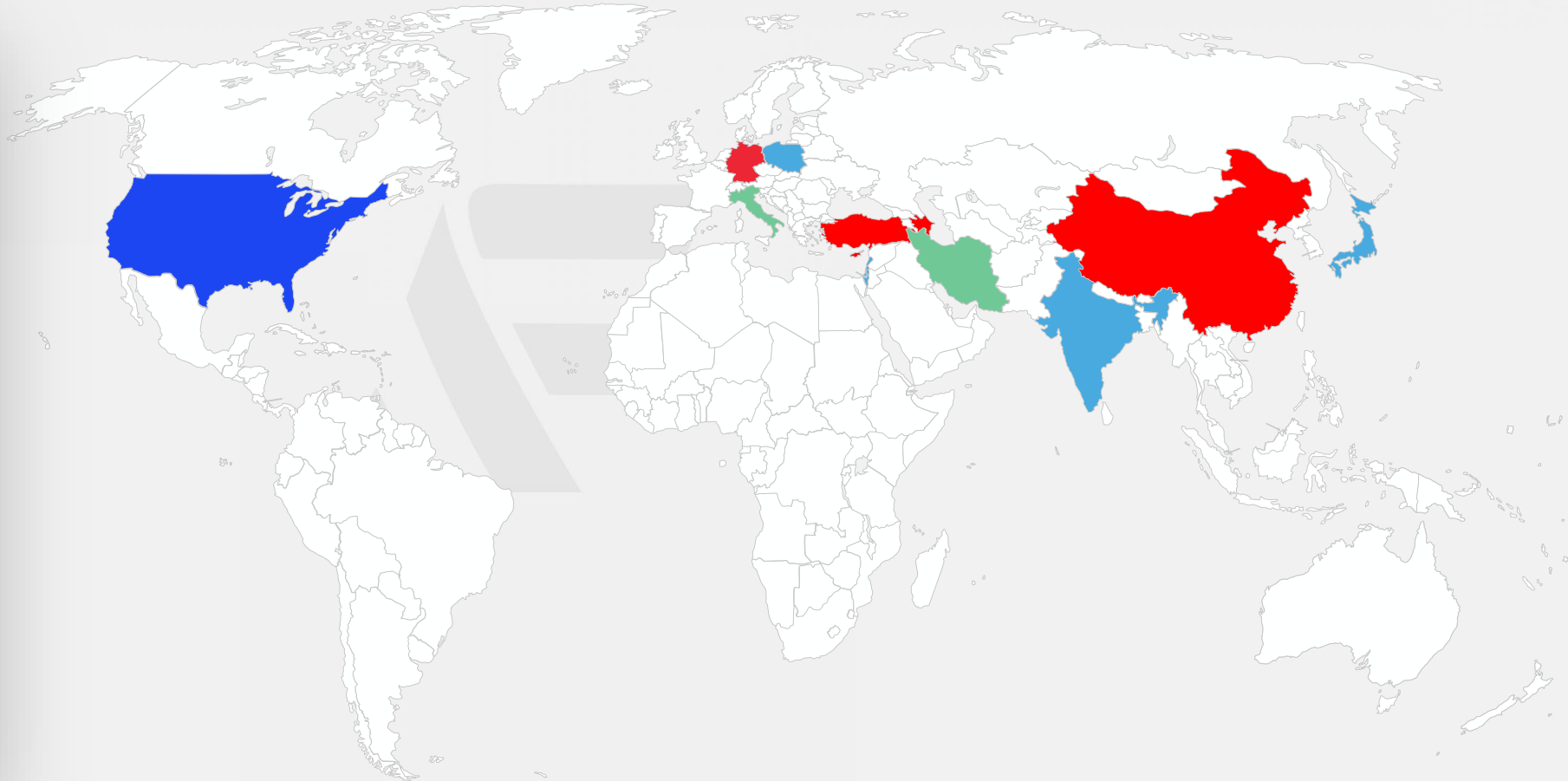


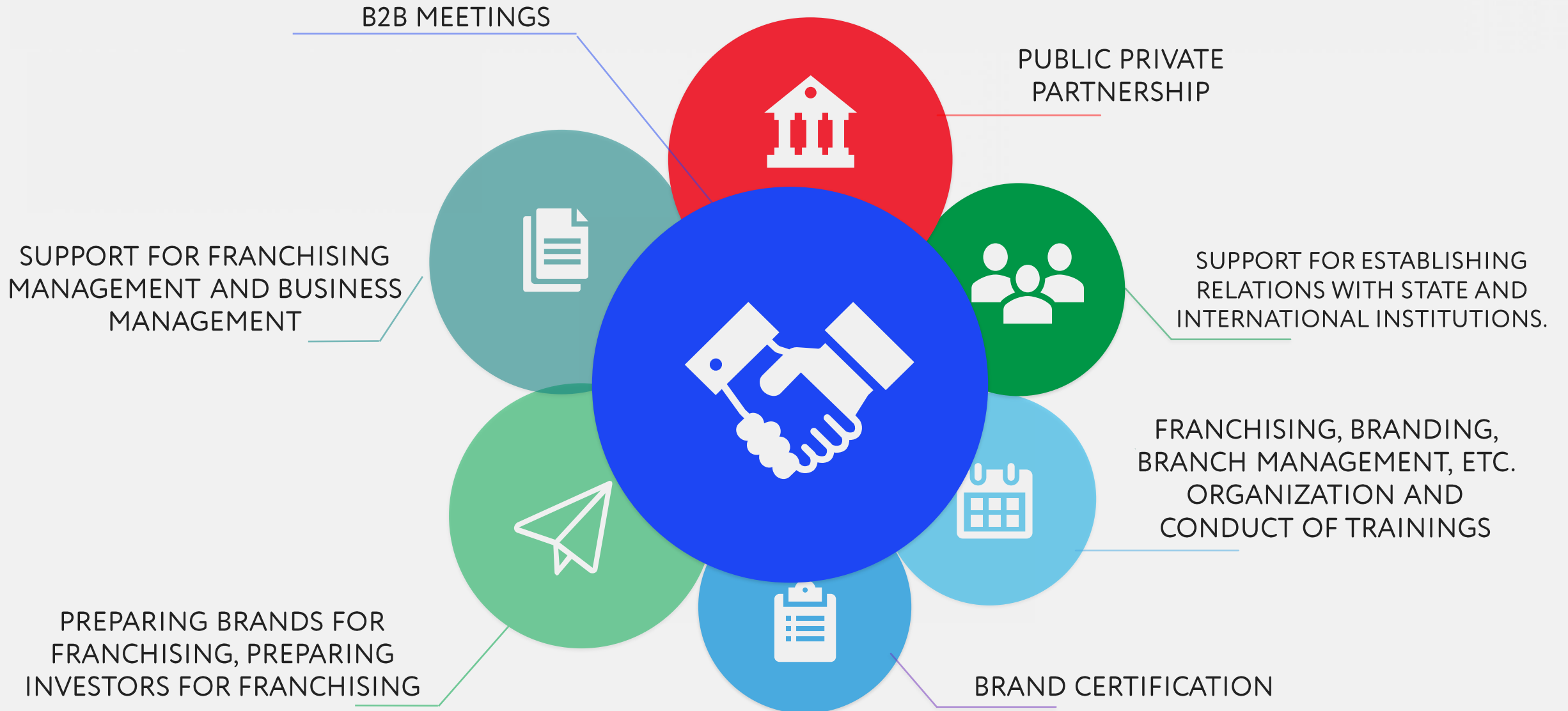
